

Certification

Any delinquent fees at the end of each 2nd quarter may be certified with the County Treasurer for collection with your property taxes as allowed by (pursuant to) Utah Code Ann. Section 17B-1-902. Any amount certified then becomes a lien on your property. Your quarterly billing statement serves as advance notice prior to certification. Certified accounts will be assessed a delinquent administrative fee of eight percent (8.0%) of the delinquent balance. The Salt Lake County Treasurer will add additional interest and penalties. The charges will continue to accumulate until the account is paid in full.

Late Fees

All fees will be billed on a quarterly basis. Any property owner not paying service fees by the due date shall be deemed delinquent and subject to a late fee of 1.5% per month (18% annual rate).

Returned Check Fee

A fee up to \$20 will be assessed on all returned payments, plus any additional fee as allowed by law.

Moving?

If a District customer sells their current home and purchases a new home in the District their account number will change. The account number is assigned to the property, not the customer.

For prompt payment processing, please ensure you are paying the account associated with your new address. Any credit balance on the customer's original account may be transferred to the new property account at the customer's request.

2022 YEARLY GARBAGE RATES

Basic/Initial Service-- One garbage and one recycling curbside can: \$204 annually, billed quarterly at \$51. The basic service also includes:

- The assist program for those who need assistance with their cans
- Fall leaf-collection sites: Refer to website for your neighborhood bag distribution location—www.wasatchfrontwaste.org
- Curbside Christmas tree collection
- Glass waste collection sites

Qualified Indigent Relief Customers--\$102 annually, billed quarterly at \$25.50

Optional / Additional Curbside Services

Additional Recycle Can—\$36 annually, billed quarterly at \$9

Additional Garbage Can— An additional \$204 annually, billed quarterly at \$51

Curbside Green Waste Can—a specially designed can for grass clippings and organic yard waste: \$60 startup fee + \$126 annually, billed quarterly at \$31.50

Additional Green Waste Can—\$60 startup fee + \$36 annually, billed quarterly at \$9

Curbside Glass Waste Can—\$45 startup fee + \$96 annually, billed quarterly at \$24

Trailer Rentals for Green Waste (\$45) and Bulky Waste items (\$175). Mattresses, refrigerators, and tires are assessed additional fees when included in the trailers; the fees are \$15, \$12, and \$3 each, respectively. Please do not hesitate to call if you have any questions about the trailer rental program.

Please note that each customer will receive one paper statement per year in April.
